Following topics were discussed at the board meeting

- 6. It was decided to move our Club bank accounts to Hatton National Bank from Sampath Bank, to make transactions easier. This was proposed by Lion Shalaka Godamune and second by Lion Heshan Padukka.
- 7. It was decided to hold the Club Charter Anniversary Celebration on end of November.
- 8. The list of members to host the monthly meetings was prepared by Lion Shehan Kahandagamage and it was approved by the directors.
